Education Committee Chair, Lisa LaGue, CTR

“The Happy Couple, Mr. Right & Mrs. Always Right”

These words are on a magnet that hangs on my refrigerator. It never fails to make me smile when I see it.

I suspect I am not the only wife who secretly longs to be the winner when it comes to disagreements with her better half, but for me, this strong desire to always be right is limited to interactions with my husband. In all other aspects of my life, I can accept that I am not always right, that I don't know everything, but... I HATE being wrong.

It's an innate human characteristic to dislike making mistakes, but not everyone reacts the same way to being wrong. I've met plenty of individuals who hate being wrong but cannot accept they are not always right. I'm often amused by the responses these individuals give rather than simply confess they made an error or did not know what was correct.

Because I am a cancer registry educator and trainer, many registrars ask me questions since they consider me to be an “expert” with all things cancer registry related (their word, not mine). While I appreciate the accolade, I will never claim to be an expert at anything. This is because there is always something to learn, whether it is something new or something old that I didn't understand correctly the first time around. It's the reason **continuing** education is required.

The main reason I continue to serve as a cancer registry educator and trainer is because I enjoy learning and I enjoy sharing my learning experiences with others. For almost two years now, I have been focused on transitioning away from Collaborative Stage to directly assigning SEER Summary Stage and AJCC Stage. The transition process started with me attending multiple training webinars so I would be able to effectively train others and it has continued with me studying the same training materials so I can be even more effective in training others.

Since I do hate being wrong, transitioning away from Collaborative Stage has been more difficult than I anticipated. Without having CS derived stages available, I've learned I have a lot more to learn about directly assigning AJCC Stage. I've learned my interpretation of AJCC rules has been incorrectly influenced by CS rules. Since CS was first required in 2004, that means I've been wrong for way too long.

I'm confessing this to you for two reasons. First, to encourage you to confess a mistake or misunderstanding. Mistakes provide learning opportunities. For 2016, workshops were focused on areas I needed additional training. For 2017, I would like to focus workshops on areas most beneficial for you. Send an email to me, at lisa.lague@comcast.net,

explaining a mistake you made, a rule you misunderstood, or an area of registry operations that you would like included in training workshops. Each person who sends a “confession” will be entered in a drawing for a prize donated by myself. The second reason for my confession is to once again promote the AJCC Curriculum for Registrars. This series of self-instructional modules is an excellent resource available for free to everyone. I’ve worked through each module multiple times and have increased my knowledge each time. The modules can be found at

<https://cancerstaging.org/CSE/Registrar/Pages/AJCC-Curriculum.aspx>. If you have not reviewed these modules, I strongly encourage you to do so. These modules were developed using the 7th edition of the AJCC Cancer Staging Manual. The 8th edition will be effective in just a few months but do not use that as excuse to not work through the modules. The modules cover general staging concepts and special rules which will still be applicable to the 8th edition.

Always right. While it would be nice to always be right, I can accept that I’m not. What about you? Do you hate being wrong? Can you accept your mistakes? Can you admit you don’t know everything? Learn from my example. Don’t rely on what you think you know. Be willing to discover if you are making mistakes. Work through the staging modules. You might discover you don’t know as much as you think you do. It’s the reason **continuing** education is required.

Just a reminder, the Indiana State Cancer Registry (ISCR) purchased the 2016-2017 North American Association of Central Cancer Registries (NAACCR) webinar series. This series is available at no cost to individual certified tumor registrars. If you would like more information, please contact Marsha Lundy at 317-233-7158.

Indiana received both the Registry of Distinction award from the NPCR and the Gold Standard award from NAACCR. This allows Indiana's data to be included in both the *Cancer Incidence in North America* and *United States Cancer Statistics* publications.

Steve Nygaard, ISCR programmer, retired at the end of June 2016. The ISCR welcomes Padmini Pasam to the role of programmer. Ms. Pasam had the benefit of working alongside her predecessor for one month prior to his retirement.

The ISCR is finishing up its Death Clearance process to ready data for November's Call for Data.

The Cancer Surveillance Section Director, Laura Ruppert, and Health Education and Communications Director, Dawn Swindle presented, *Using Cancer Registry Data to Enhance Comprehensive Cancer Control Communication Efforts and Populating Hospital Cancer Registry Data into Survivorship Care Plans: A Test Run*, at the National Cancer Registrars Association (NCRA) annual conference held in Las Vegas, NV, April 10-14, 2016.

The ISCR participated in the first regional cancer registry meeting between Indiana and Ohio in Ft. Wayne, IN, on May 25, 2016. The focus of this meeting was lung cancer.
