INDIANA STATE CANCER REGISTRY Laura Ruppert, MHA

Just a reminder, the Indiana State Cancer Registry (ISCR) purchased the 2017-2018 North American Association of Central Cancer Registries (NAACCR) webinar series. This series is available at no cost to individual certified tumor registrars. If you would like more information, please contact Marsha Lundy at 317-233-7158.

The ISCR submitted data to both NAACCR and the Centers for Disease Control and Prevention's (CDC) National Program of Cancer Registries in November 14, 2017. Results of the quality, timeliness, and completeness are pending. **Both of these submissions directly reflect of the outstanding work of CTRs across Indiana.** If the data are acceptable Indiana will be included in the *Cancer Incidence in North America* and the *United States Cancer Statistics* publications.

Indiana submitted the continuation proposal for funding to the Centers for Disease Control and Prevention (CDC), Cancer Prevention and Control Programs for State, Territorial Organizations, CDC-RFA-DP17-1701. This is the federal funding for our state cancer registry.

On the Horizon

The Indiana Cancer Consortium (ICC) Annual meeting: April 26, 2018 to be held at Ivy Tech Conference Center. Look for details to be released soon by the ICC on how to register for this event. This is a wonderful event for statewide CTRs to attend as all of the data you collect is highlighted.

Utilizing cancer data collected from reporting entities in Indiana, Cancer Surveillance Section Director, Laura Ruppert, MHA submitted a success story to the National Program of Cancer Registries entitled, *Linkage of Indiana State Cancer Registry and Indiana Network for Patient Care* data. This will be on display at the annual NCRA Conference in New Orleans, LA, May 20-23, 2018.

To date the only update that has been posted is NAACCR Site-Specific Data Items Task Force (SSDI) posted draft versions of both the SSDI manual and the grade manuals for review and comment. We are still awaiting the announcement of the STORE Manual release from the Commission on Cancer. It was expected to be released in February. Continue to watch for announcements from CoC and ICRA regarding the releases.

AJCC 8th edition Staging did begin with cases diagnosed beginning 1.1.2018. This will be a learning experience for all of us and I'm sure that together we will learn all of the hidden keys as we advance into this new staging system.

In other news: In December it was announced by NCRA that Registrars now have their own special Standard Occupational Classification (SOC) system. This has been a long time coming and will finally allow registrars to be classified by the Bureau of Labor Statistics more accurately. To learn more about classification go to

It only seems right to share it again twenty years later during this our 40th year. I'm sure many of our members will be reading this for the first time. Over the years ICRA historians have documented annually ICRA highlights: association accomplishments, the past presidents, the distinguished members and presidential award winners. So we can "Watch the ICRA Seed Grow"...

ICRA History

The ICRA seed was planted in 1977 by N.D. Ewing, MD and Vesta Davis, CTR from Good Samaritan Hospital in Vincennes, Indiana; and Ardythe Hester, CTR from Welborn Hospital in Evansville, Indiana. They saw a need for a cancer registrars professional organization and contacted other southern Indiana registrars.

On April 5, 1978 the first cancer registrars meeting was held at Good Samaritan Hospital in Vincennes.

Eight charter members established the Southern Indiana Tumor Registrars Association's charter, collected dues, elected officers, and developed the organization bylaws.

The eight charter members of the Southern Indiana Tumor Registrars Association (SITRA) were:

- Ardythe Hester, CTR, Welborn Hospital, Evansville

- Bernice Martin, Regional Hospital, Terry Haute
- Diana Carter, St. Mary's Hospital, Evansville
- Mary Fehrenbacher, Deaconess Hospital, Evansville
- Sue Schnarr, St. Joseph's Hospital, Huntingburg
- N.D. Ewing, MD, Good Samaritan Hospital, Vincennes

The Seed Began to Sprout...From a Seed to a Plant...

The eight charter members planted the ICRA seed, nurtured the plant, and watched it grow larger and larger.

In 1983 the organization's title was changed to the State of Indiana Tumor Registrars Association.

In 1986 association president Valerie Brown, RN, BSN, CTR gave ICRA a "shot of Miracle Grow." That year our organization's name was changed to its present name of Indiana Cancer Registrars Association (ICRA). ICRA became a tax-exempt organization and liaisons with the Indiana Health Information Management Association (IHIMA) and the National Cancer Registrars Association (NCRA) were established.

Since 1986 many members have continued watering and nurturing our plant to what it is today – an outstanding professional cancer registrars association to be proud of. Without the efforts of our members working together, our ICRA plant would have wilted many years ago.
